Chairman Don McCord called the meeting to order at 1:00 p.m. Introductions were made, and a sign-in sheet was circulated.

Minutes of the Previous Meeting

Chuck Couture made a motion to accept the September 21, 2023, minutes with corrections noted. Deb Root seconded the motion and it carried.

Correspondence

There was no correspondence.

Project Review Report

Secretary, Robert Keis made a motion to acknowledge receipt of the Project Review Report, Vice Chairman Kier Dirlam seconded the motion and it carried.

Executive Director's Report

1. FY2024 Appropriations Update

President Biden signed a continuing resolution after Congress passed a last-minute bill to avoid a federal shutdown. The bill provided over \$18 billion to communities struggling after natural disasters.

2. LDD/EDA 2024 Applications

Board approval was needed to submit STW's yearly application to ARC in the amount of \$300,000 and to EDA in the amount of \$70,000. Don Benson so moved, Chuck Couture seconded the motion and it carried.

3. IIJA (Infrastructure Investment and Jobs Act) Funding

- Southern Tier West was allotted \$1,185,000 for 2022 and again for 2023. Over the five-year period that equals \$5,925,000 for IJA designated projects through FFY2026.

4. <u>CEDS</u>

Staff is fine-tuning the 2023 CEDS document and a link will be sent to the US Department of Commerce Economic Development Administration for final approval.

5. IEDC ERC Program

Southern Tier West's project has been selected to advance to the ERC match interview stage. The Fellow responsibilities and scope of services will provide the southern tier west region with a dynamic, in-person business skills training program that will meet the unique needs of individual locales and business communities, while building social capital and trust within each learning cohort. The scope of services includes business skills program design, community organizing and entrepreneurial culture building, and regional business development strategic planning.

6. STW IIJA Project Proposal

The Southern Tier West IIJA project proposal is "Conserving Farmland Assets and Transitioning Farms to the Next Generation" in the amount of \$200,000. Products of the proposal include regional LESA analysis of high priority farmland combining soil classifications, ag exemptions, ag districts, and on-farm investment and infrastructure assets; transition planning services for farm business owners; strategic plan for conservation easement program to assist farms in transition; and educational materials on farmland conservation for municipalities and the public. The goals include maintaining a strong agricultural asset base and following through on county agricultural development and farmland protection plans.

Kier Dirlam reported that Allegany County is working on a Hazard Mitigation Update.

Rebecca Wurster reported that Chautauqua County is working on a County-wide Housing Market Study and Analysis and that Chautauqua County recently approved funding from its American Rescue Plan Act allocation to build out broadband infrastructure across the county, specifically in those areas that are unserved and underserved.

Deb Root reported that Allegany County completed a Strategic Plan for Economic Development.

Carissa Knapp reported that a GIS Study (Needs Assessment of the County) for Allegany County is being completed.

Kortney Keyes reported that the Seneca Nation is meeting on their IIJA Project to complete budget work, and the Seneca Nation is doing a Feasibility Study on the Oil Springs Reservation.

Angie Kennedy reported that the Seneca Nation received a grant from NYS DOT to build a new bus facility, and they have started a circulator route for the Seneca Transit System. The Seneca Nation received a grant for a regional transit hub on Routes 5 & 20.
