Local Government Program

The Fall Planning & Zoning Training is scheduled for November 15th at JCC, Jamestown Campus and November 16th at the STW BOCES Center. Registration begins at 3:30 p.m. followed by Planning & Zoning: An Intro (2) hours PZ Credit) 4-6 p.m.; Joint Boards (1 Hour PZ Credit) 6:30 -7:30 p.m.; and Short-Term Rentals (1 Hour PZ Credit) 7:30 - 8:30p.m. Christopher Eastman and Paula Gilbert from NYS Department of State will be presenting the classes.

The first webinar in the Floodplain Management Training Series is being held October 19th, entitled "Flood Insurance Rate Maps, Elevation Certificates, and Letters of Map Change" being presented by Brad Wenskoski, CFM, NYS Department of Environmental Conservation. Two hours of code credit are being offered to attend this webinar.

Staff has been doing records management at the City of Salamanca.

Southern Tier Extension Railroad Authority (STERA)

STERA, in conjunction with WNYPRR, submitted an application in the 2023 NYSDOT PFRAP funding cycle for a Bridge and Tie and Rail Replacement PFRAP Project. The STERA Board authorized submission of an application for \$1,947,550 of NYS DOT PFRAP grant funds, to be matched by \$834,664 of WNYP funds. STERA also had undertaken the SEORA review and issued a negative declaration on the project.

The project as initially proposed involved replacement of 8,400 ties, replacement of some worn rail, and surfacing between Allegany (Cattaraugus County) to Niobe (Chautaugua County), between MP JC-397.86 to MP CE-1.55 (Niobe).

WNYP's current project proposal includes:

- 1. Replacement of timber decks and installation of welded rail across up to 18 bridges between Allegany, NY and Niobe, NY (PA State line).
- 2. Installation of up to 8,000 new crossties at various locations across the Freight Main Line between Falconer, NY and Niobe, NY.
- 3. Ballasting, alignment, and surfacing of all areas which receive new ties.
- 4. Proper disposal of all replaced bridge timbers and crosstie.

Economic Development Administration

Economic development staff submitted the region's 2023-2028 Comprehensive Economic Development Strategy to the EDA in October. The plan lays out a vision for the region's progress using five strategic pillars of Natural Environment, Built Environment, Business and Industry, Human Capital, and Vibrant Communities. The final draft of the plan is available for the public to read at www.southerntierwest.org, and will also be printed in November for distribution to libraries and municipalities across the region.

GIS Program

At the request of Chautauqua County DPF, STW created highdefinition base maps of a region in Niobe where beaver dams and flooding have been an ongoing issue. These maps were created utilizing our DJI Mavic Pro Enterprise drone system and Pix4D mapping software. STW's drone and mapping capabilities allow a municipality access to areas that would normally be too remote or inaccessible for inspectors to reach by conventional means. The data acquired from these missions is crucial for municipal officials to assess the situation and build a roadmap for rectifying it.
