Local Government Program

Southern Tier West is hosting a **Floodplain Management Training Series**. The first class in the series is "Flood Insurance Rate Maps. Elevation Certificates, and Letter of Map Change" being held on October 19th on GoToWebinar from 1-3:15 p.m. hosted by NYS Department of Environmental Conservation. The second class is "An Intro to the National Flood Insurance Program" being held on October 25th from 1-2:15 p.m., hosted by Southern Tier West. There will be two more webinars scheduled in the Spring to complete the series. Code Enforcement Officers can earn 4 credit hours for attending these webinars.

Registration is available for the 2023 Fall Planning & Zoning **Training** taking place on November 15th at Jamestown Community College, Jamestown Campus and on November 16th at Salamanca BOCES Center from 4:00 - 8:30 p.m. Training topics include: Planning & Zoning - A Refresher: Joint Boards: and Short Term Rentals. Christopher Eastman and Patricia Burke will be coming down from NYS Department of State to present these classes.

Economic Development Administration

Economic development staff completed a draft of the region's CEDS, which is a fiveyear economic plan, on August 22. CEDS (pronounced "seds") stands for Comprehensive **Economic Development** Strategy. The plan's content was created by over 110 participants in focus groups and phone calls, envisioning the region's progress over the next five years. All focus group participants have been notified that the plan has been released for its 30-day public comment period. ARC Funding Program

Applicants are gathering their final signatures and support letters to be sent for state review on October 1. Projected approval and start of the projects is June 2024; 3 of the 4 projects are construction based and USDA's Rural Development is stepping up to oversee as the Basic Agency administrator.

Chautauqua and Allegany Counties are working on finalizing their applications that will work on preliminary stages of an Industrial Park and developing sewer and municipal water to promote growth and attract commercial interest. Seneca Nation and Cattaraugus County are on track to tap into their funding for projects with meaningful regional impact.

Academies. One major change to the program is that youth will meet over an 8-week period in the fall, instead of the elongated calendar stretching from October to June.


- Completed a Drinking Water Source Protection Program (DWSP2) Plan with the Village of Portville and is in the process of final review from NYSDEC.

GIS Program

STW currently has 37 communities actively participating in the Community GIS program and over 3,000 data points have been collected using the program. As of September 1, 2023 the program has 15 unique surveys available for municipalities to utilize including Active Farms, Cemeteries, Code Enforcement, Cross Pipes, Culverts, Drop Inlets, Forestry, Guard Rails, Hydrants, Main Street Analysis, Manhole/Sewer, Water Shutoff, Signage, Streams/Rivers, and Road Tiles. STW is also working with municipal highway departments and soil and water conservation districts to incorporate new surveys into the system. STW continues to hold monthly training and Q&A sessions concerning the CGIS program. These trainings are open to anybody interested in the CGIS program and are held on the 4th Wednesday of the month from 11:00 AM until 1:00 PM at the STW offices.
