Driving Strategic Implementation: CEDS Focus-To-Action Groups Now Forming

Southern Tier West is moving forward with the implementation phase of the 2023-2028

Comprehensive Economic Development Strategy (CEDS) by

launching the first round of Focusto-Action Groups. These collaborative groups will help translate regional priorities into actionable, partner-led initiatives. With nearly 200 recommended actions across 33 core objectives, the CEDS provides a strategic roadmap for building a more vibrant, resilient regional economy. Drawing on input from late 2024 stakeholder engagements, STW will convene groups in the following sectors:

- Arts, Culture & Tourism
- Business, Industry & Entrepreneurship
- Economic Drivers of Community Health & Wellness

Upcoming Focus-to-Action Sessions

All initial meetings will be hosted via Zoom:

- Arts, Culture & Tourism -Monday, May 19 | 1:00-2:15 PM
- Business, Industry & Entrepreneurship - Tuesday, May 20 | 9:00-10:15 AM
- Community Health & Wellness - Thursday, May 22 | 10:00-11:15 AM

Follow-up meetings will include a mix of virtual and in-person formats.

These groups will work to:

- Engage the right mix of regional partners
- Identify implementable projects aligned with CEDS priorities
- Explore funding opportunities
- Align efforts with EDA goals, such as workforce competitiveness and economic resilience

These sessions will also elevate visionary ideas, support underrepresented sectors, and emphasize the interconnected roles of public health, food systems, and cultural assets in shaping a strong and inclusive economy.

Community GIS Program

Currently, 26 communities across Chautauqua, Cattaraugus, and Allegany Counties are actively participating in the Southern Tier West (STW) Community CGIS Program. To date, these municipalities have used the system to collect over 7,250 data points on vital municipal assets such as signs, culverts, shut-offs, hydrants, and cross-pipes—directly from their mobile devices while working in the field.

These asset inventories have proven essential for effective management, planning, and decision-making, and the data is instantly accessible for viewing and editing on custom, user-friendly maps.

We currently have open enrollment spots available and would be happy to schedule a meeting with your community to discuss the program, demonstrate its capabilities, and explore the benefits it can offer your municipality.

Southern Tier West (STW) has rolled out a **Municipal Needs Assessment Survey** to gather essential information from municipalities across our region. This initiative is designed to identify local needs, improve support, and align communities with valuable programs and resources.
